5 Distinguished = **Distinguished rating**

3 Proficient; 3 Accomplished; 1 Distinguished = **Proficient rating**

2 Proficient; 3 Accomplished; 2 Distinguished = **Accomplished rating**

1 Proficient; 3 Accomplished; 3 Distinguished = Administrative decision **Accomplished/ Distinguished**
