No.	Goal	Identified Group	Rationale/Sources of Evidence
1	Differentiated Instruction Build the capacity of all teachers to differentiate instruction and engage all students in their classrooms to meet the needs of all learners.	4-8	<ul style="list-style-type: none"> ➤ Teacher survey (administered April 2017) indicates a need for additional professional development in the area of differentiated instruction (42%) and student engagement (51%). ➤ Teachers and school leaders have raised concerns regarding differentiated instruction and student engagement during grade level meetings. ➤ Analysis of the types of interventions put in place in student action plans developed by the I & RS committee and Child Study Team indicate a need for professional development in this area. ➤ School leaders and special education services have identified a need of differentiated instruction for students with learning disabilities such as dyslexia.
2	Data Analysis and Assessments Support teachers in analyzing state and local assessment results, modifying instruction to meet student needs and reassessing to monitor growth.	4-8	<ul style="list-style-type: none"> ➤ Teacher survey (administered April 2017) indicates a desire to increase their knowledge of analyzing student data from local and state assessments (31%) and to increase their knowledge of LinkIt! (39%). ➤ Teachers have requested professional development take place in a small group workshop setting (58%).
3	New Jersey Student Learning Standards (NJSLS) Assist teachers in understanding the increased rigor of all state standards and their impact on lessons, curriculum and state assessments.	4-8	<ul style="list-style-type: none"> ➤ Teacher survey (administered April 2017) indicates a need to increase their knowledge of the NJSLS for English Language Arts/Literacy (35%) and ELA tasks associated with PARCC (29%). ➤ The district and school have identified the need for professional development to increase the rigor in classrooms in order to meet the NJSLS and their impact on lessons, curriculum and assessments.
4	Integrating Student Use of Technology Build the capacity of all teachers to regularly infuse the use of technology in their classrooms to meet the needs of all learners.	4-8	<ul style="list-style-type: none"> ➤ Teacher survey (administered April 2017) indicates a need for professional development in student use of technology (59%), Google Classroom (80%), Google Docs (46%) and NewsELA (40%). ➤ Teachers have requested more professional development in these areas during component and grade level meetings. ➤ School and district leaders realize the importance of students using technology as a vehicle to learning and have made a commitment to support teachers in this endeavor.
5	STEM Support teachers in increasing their level of awareness of science, technology, engineering and	4-8	<ul style="list-style-type: none"> ➤ Teacher survey (administered April 2017) indicates a desire for professional development STEM (25%), Mathematics standards (18.18%), Inspire Science (14.55%) and Global Awareness (15%). ➤ Teachers have requested professional development during small group workshops. (58%).
