GHS has been randomly selected to participate in the University of Michigan's "Monitoring the Future" project. This annual survey, funded by the National Institutes of Health, has been tracking changes in the attitudes, opinions, and behavior of American young people for the past 40 years. The resulting research has been featured in publications such as *Newsweek* and *Time*. Our 12th grade students will be asked to complete a 45-minute questionnaire which asks about school experiences, attitudes towards school & education, plans for the future, use of and attitudes about using alcohol and drugs, work experiences and preferences, and health & leisure activities. There are no questions about sexual behavior or abortion. Students are informed that their participation is voluntary and that they may skip any questions that they wish. At least three weeks prior to survey administration, parents are sent a notification letter of their child's participation in this survey---they do have the opportunity to opt their child out of participating in the survey. Both the school's participation and student responses are kept completely confidential. No school staff are involved in administering the questionnaires---professional field researchers from the University of Michigan would come to GHS this spring to administer the survey. GHS will be paid \$500 for participation. The principal will receive an *Individualized School Report* reflecting our students' responses.
