
Gloucester City Public School District is exempt from New Jersey Sales Tax.

According to the New Jersey Division of Taxation regulations:

Local school districts, as political subdivisions of the State of New Jersey, are exempt from the New Jersey Sales and Use Taxes, pursuant to Section 9(a) of the New Jersey Sales and Use Tax Act. Federal and New Jersey government agencies are not issued an ST-5 certificate. Proof of exemption is the government purchase order or contract and direct government payment.


When purchasing items for the use of the local school district, an exempt organization certificate is not required. The official letterhead of the school district signed by the proper school officer is sufficient proof to the vendor that local school district is exempt from paying sales taxes.
